Collection Date – 29<sup>th</sup> July 2026 – Collection Time (Strictly 4.00pm – 5.00pm)

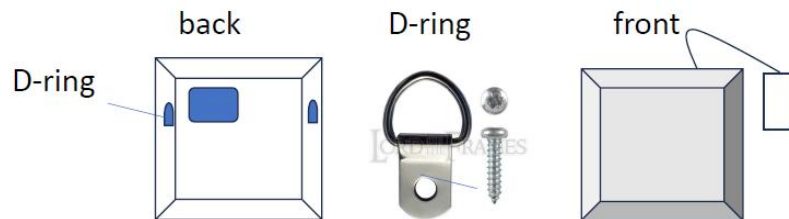
#### **Schedule of Rules for Exhibiting Artists**

**Membership** – In order to take part in this exhibition you must be a fully paid-up WSA member for the duration of the exhibition. If your membership is due to lapse during the exhibition, you will be required to renew your membership prior to hanging day. (Your renewed membership WILL start from the correct date, and you will not lose any time on your membership. This is important. If in doubt check with us)

**Hanging** – Is the responsibility of the WSA exhibition team, in conjunction with the Rose Paterson Gallery. They have final say on hanging.

**All framed artworks to be done so to exhibition standard** – (Canvases do not need to be framed but must be presentable around the sides and edges, if they are not framed).

- Clip Frames are NOT allowed.
- D-Rings are to be correctly fitted 1/3<sup>rd</sup> of the way down the work, facing inward with string between
- Two labels – One on the back and one hanging over the work to be viewed from the front (Luggage Label) all clearly giving the artist's name, title of the artwork, medium and price.
- **Any artworks with substandard frames / framing or preparation will be rejected.**



**All works must be for sale** – Artists may also sell cards and prints throughout the duration of the exhibition. For which, a full and comprehensive list of all stock must be provided beforehand.

**Price Labels** – These will be produced by Rose Paterson Gallery and will be taken directly from the information that you provide in your submission form.

**Insurance** – Exhibitors are responsible for insuring their own work.

**Copyright** – ALL exhibited artwork must be your own original work and must not infringe any copyright including (but not exclusive to) using photographs and images taken / created by others.

**Delivery day** – Please ensure that you arrive promptly and to the times above.

- Sign your work in with the exhibition team and gallery staff
- Take all wrappings away with you.

**Collection** – Is on Thursday 29<sup>th</sup> July between 4.00 and 5.00pm. Please arrive promptly and on time.

**Pricing** – Please work out the price of your artwork to include the gallery's commission which is 30% (Plus VAT).

**Sales** – All payments will be made by the gallery to The Walsall Society of Artists after the exhibition has ended. The society, upon receipt of this payment, will then pay the artists. This process can take around eight to ten weeks, from the end of the exhibition.
