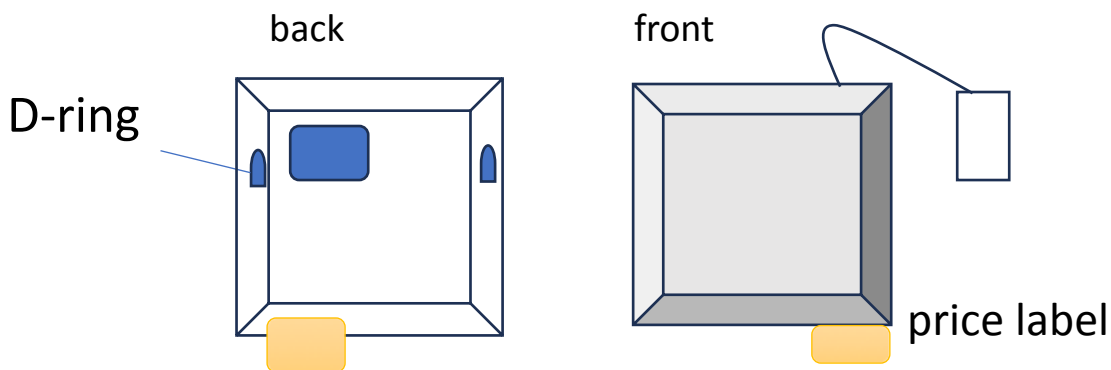

## Terms & Conditions for Exhibiting Artists.

1. **Hanging** the exhibition is the responsibility of the exhibitor/s.
2. **All works to be framed and glazed to EXHIBITION STANDARDS, (Canvas & Board Optional).**
  - No clip frames.
  - D-rings to be fixed 1/3<sup>rd</sup> of the way down the work, facing inwards.
  - Three labels. One on the back and one hanging over the work to be viewed from the front, price label front, all giving name, title, medium and price.
  - No labels to be attached to the walls.



3. **No work of an offensive nature accepted** i.e. nudism, racism. All work must be in keeping with the venue showing respect for the building of St. Pauls Church.
4. **Exhibitors are responsible for the insurance of their own work.** There will be no responsibility taken by St Pauls Gallery, The Crossing.
5. **Hanging day**, is on the last Friday of the month, from 8.00am to 11.30am, all wrappings to be taken away by the individual exhibitor/s.
6. **Removal day**, is on the last Thursday of the Month between 2.00pm - 5.00pm
7. **Sales of work**, this is the responsibility of the Exhibitor, currently no commission is charged.
8. **Promotional Material** ie posters, images, artist bio, etc need to be forwarded to the office at St Pauls Gallery at The Crossing, four weeks before the exhibition commences so they can promote the exhibition. You agree to your artwork to be photographed and used to promote the exhibition.
